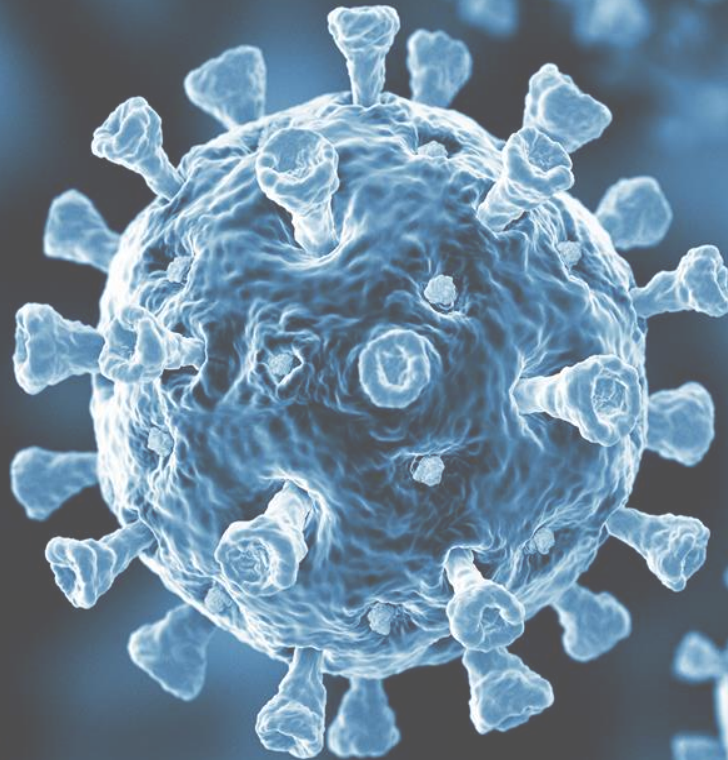

LEVEL 3

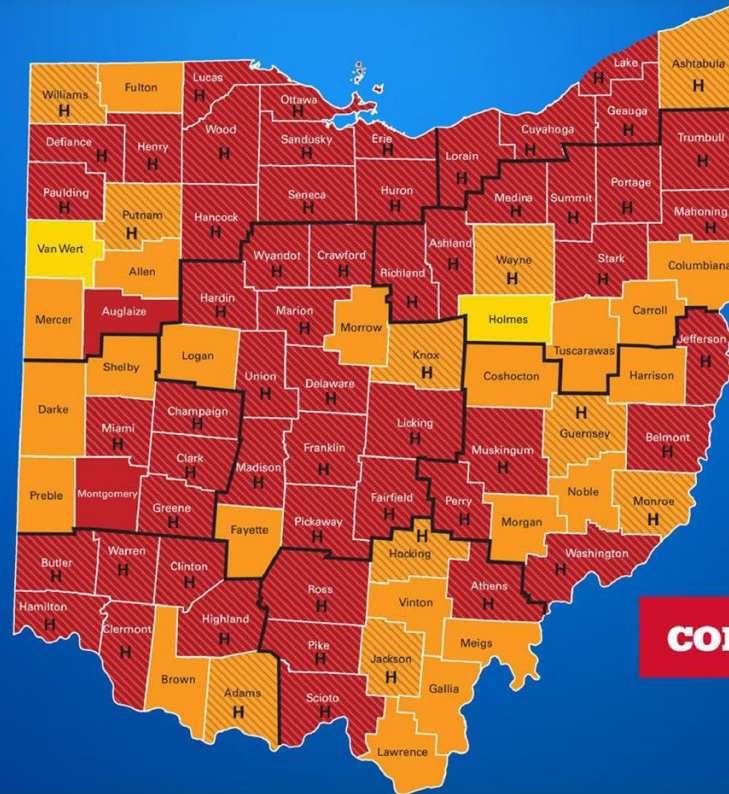
Public Emergency

Ohio's COVID-19 vaccine enrolled providers

- Ohio currently has more than 3,000 enrolled vaccination providers.
- Enrollment remains open for interested and eligible providers.

Pfizer says its vaccine is 'extremely effective' in children

Pfizer announced Wednesday that its coronavirus vaccine was extremely effective in children ages 12 to 15 during clinical trials.



No infections were found among children who received the vaccine in a recent clinical trial, according to Pfizer.



The children produced strong antibody responses and experienced no serious side effects.



Detailed data has not been shared yet, and the data has not been peer-reviewed, but it is an important step in the process of gaining FDA authorization for use in children.



Children younger than 18 account for about 23% of the population in the United States.

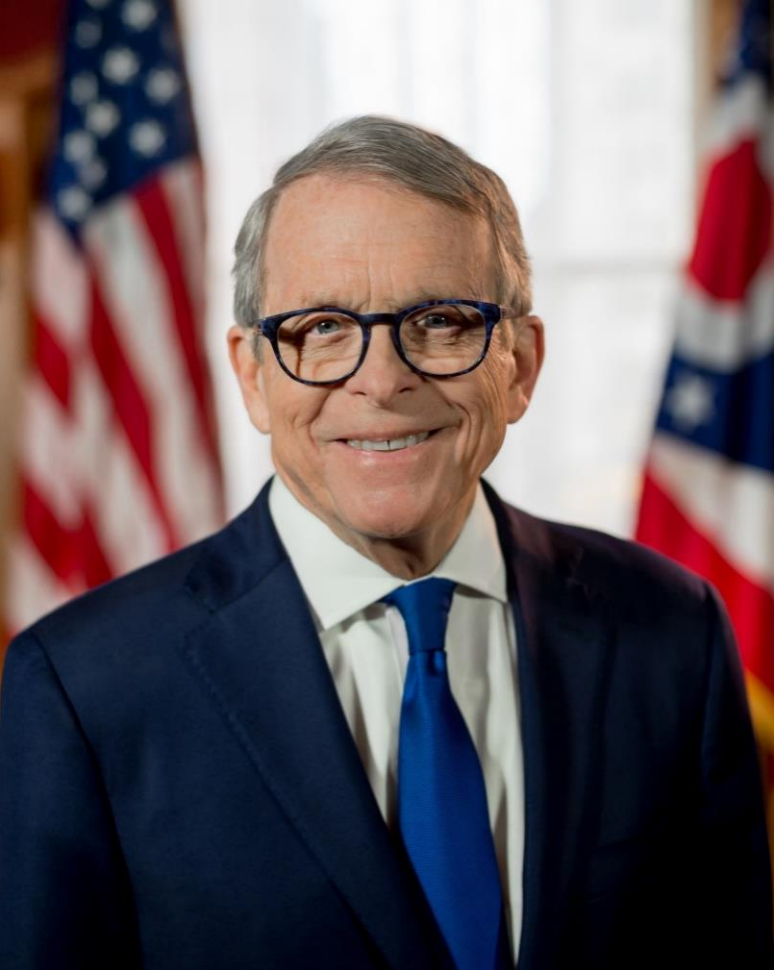

COVID-19 cases in long-term care facilities continue to decline

Two weeks ago, Ohio's long-term care facilities reported just 70 new COVID-19 cases, compared with:

- 157 new cases reported the previous week.
- 2,832 new cases reported at the peak of the pandemic in December.

A total of 93% of Ohio's nursing homes and 77% of assisted living facilities have signed up to get additional vaccine for new staff and new residents through Ohio's COVID-19 Vaccine Maintenance Program coordinated by the Ohio Department of Aging.

Ohio's Vaccination Program

A Phased Approach

PHASE 2D



**Beginning
March 29, 2021**

Phase 2D will open the vaccine to **all** eligible Ohioans age 16 and up.

Individuals ages 16-17 will be eligible to receive the Pfizer vaccine, the only COVID-19 vaccine authorized for use for those under age 18.

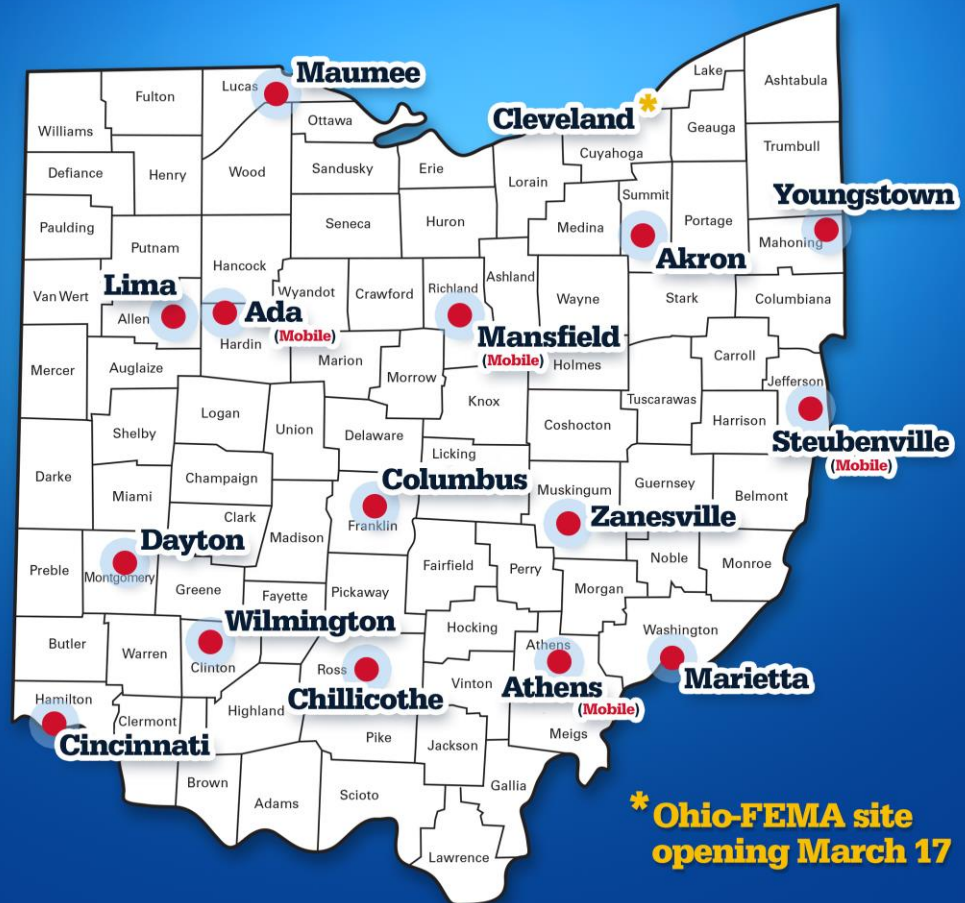

New eligibility and scheduling tool for Ohioans

To help prevent scheduling challenges for both patients and providers, the Ohio Department of Health is offering a new vaccine management tool.

It is a one-stop shop for patients beginning the vaccination process to determine eligibility, schedule appointments, submit health information, and receive updates and reminders.

ODH has been working with vaccine providers to integrate their current systems into VMS. Providers are required to use this system or another electronic scheduling system that interfaces with this portal.

Indoor Air Quality Assistance Program

The Ohio Bureau of Workers' Compensation has expanded the eligibility of the COVID-19 Indoor Air Quality Assistance Program.

- Provides reimbursements to eligible applicants to help cover the costs of inspections, assessments, maintenance, and improvements to indoor heating, ventilation, and air conditioning systems to control the spread of COVID-19.
- Provides reimbursement for secondary devices designed to destroy bacteria, mold, and viruses.

Launched in December, this \$28 million federally funded program targeted nursing homes, assisted living centers, and adult day centers that invested in HVAC improvements that weaken COVID-19's spread.

The expanded eligibility extends to intermediate care facilities, hospices, senior centers, adult care facilities, waiver settings (group homes), and substance-use treatment centers.
